WHO CAN BECOME A MEMBER?

Regular Membership consists of individuals who are employees of a public agency, or quasi-governmental non-profit agency located within the State of Florida, and who holds a position as a professional procurement officer, or other related position, and students or professors in the field of study of Public Administration or Public Procurement.



IS THERE ANY OTHER PATHWAY TO MEMBERSHIP?

Honorary Membership is reserved for all members of the Association, as well as members of other public procurement associations, who have retired from the public procurement field, unless otherwise ineligible.

Academia Membership - Academia working at or students attending colleges, universities and other educational institutions in the field of public procurement, supply management, business or public administration

COLLEGE EDUCATION REIMBURSEMENT (CER) PROGRAM

- **Eligibility:**

Any regular member who has fully paid their membership dues for the current year and the past year to the date immediate indicated on the CER Application shall be eligible under this program.

- **Qualifications** Members who take approved course work leading to a degree in business administration, public administration, or other degree directly related to purchasing. Including Tuition, Books and Lab Fees.

- **How much am I allowed to earn?**



COLLEGE EDUCATION REIMBURSEMENT (CER) PROGRAM

- For graded undergraduate courses leading to an AS, AA, BS or BA degree, members achieving a grade of “C” or above shall receive a refund of 100% of their paid tuition, books and material costs. Members may request reimbursement for no more than **\$2,000 per year.**

Purpose and Intent:

FAPPO SCHOLARSHIPS

○ **Scholarships Available:**

Scholarships may be utilized for the following events:

- Certification Application, Examination and recertification Fees.
- Members will be reimbursed at the current UPPCC/ISM/Certifying Board fees for members and non-members for Fees will only be reimbursed after providing proof of passing/certified status.

FAPPO SCHOLARSHIPS

- The purpose of the Scholarship Program is to assist the FAPPO membership in their efforts to achieve individual professional development.



NORMA SHOWLEY SCHOLARSHIPS

- A scholarship fund that will afford a member with an additional \$500 per year toward continuing education.
- The purpose of the fund is to provide FAPPO members with flexible training option to pursue other training that is beneficial for continued professional growth, but may not be degree seeking or core NIGP classes.

BY-LAWS ARTICLE 5, SECTION 3 MINIMUM REQUIREMENTS FOR BECOMING AN OFFICER

- MEMBER IN GOOD STANDING THREE OF THE LAST FIVE YEARS, GOOD STANDING IS DEFINED AS NO LAPSE IN MEMBERSHIP
- HOLD AND MAINTAIN A PROFESSIONAL PROCUREMENT, CONTRACT ADMINISTRATION, OR MATERIALS MANAGEMENT CERTIFICATION FROM A UNIVERSALLY RECOGNIZED PROFESSIONAL ASSOCIATION



BY-LAWS ARTICLE 5, SECTION 3 MINIMUM REQUIREMENTS FOR BECOMING AN OFFICER

- SERVED AS CHAIR FOR ONE OF THE FOLLOWING FAPPO COMMITTEES: FAPPO BUCKS, FINANCE, PROFESSIONAL DEVELOPMENT, SPECIAL EVENT/BANQUET, TRADE SHOW
- HAVE ENTITY SUPPORT AS EVIDENCED BY A LETTER FROM THEIR SUPERVISOR INCLUDED WITH NOMINATION FORM
- COMPLETE THE CANDIDATE CERTIFICATION FORM
